

### Curate Your Space Program – Terms and Conditions (Guidelines and Prohibitions)

Our Curate Your Space program provides collectors with a unique opportunity to experience curated works of art in their personal environments before committing to a purchase. This offering is designed to deepen the connection between the artwork and its surroundings, allowing collectors to make informed decisions about how each piece complements their home or office. To ensure a smooth and enjoyable process, the following guidelines and prohibitions outline the key responsibilities and expectations for both the collector and the gallery.

#### \*\*Guidelines\*\*

## 1. \*\*Maintain the Integrity of the Artwork\*\*

Collectors are entrusted with preserving the condition of the artwork during the experience period. It is imperative that the artwork is handled with care and displayed in an environment that ensures its protection from potential harm. Avoid handling the artwork excessively, and ensure it is positioned away from hazards such as high traffic areas, excessive heat, humidity, or direct sunlight.

## 2. \*\*Adhere to the Experience Period\*\*

The experience period is agreed upon in advance, allowing the collector ample time to assess the artwork's compatibility with their space. Collectors are encouraged to engage deeply with the piece during this time, observing how it enhances the aesthetic and atmosphere of the chosen setting. Should you require more time or wish to retain the artwork permanently, please inform us before the period ends to avoid disruptions or additional fees.

#### 3. \*\*Ensure Safe and Timely Return\*\*

At the end of the experience period, collectors are responsible for returning the artwork in its original condition. You must take all necessary precautions during the return process, including using appropriate packaging materials and arranging for professional shipping. The artwork should be shipped back by the agreed-upon date, unless other arrangements have been made. Late returns or damage may result in additional fees.

#### 4. \*\*Communicate Any Issues Promptly\*\*

Open communication with the gallery is essential throughout the experience period. If any concerns arise—whether it's damage to the artwork upon delivery or during the period, or any issues regarding



the artwork's condition—please notify us immediately. Prompt reporting ensures that we can take the necessary steps to address the situation effectively.

## 5. \*\*Utilize Professional Shipping Services\*\*

The collector is responsible for the shipping of the artwork to and from the gallery, including all associated costs. Shipping must be arranged through professional carriers who specialize in transporting fine art, ensuring the artwork is adequately packaged and handled with care. This guarantees the artwork's integrity during transit. Failure to do so may result in liability for any damages that occur during shipping.

## 6. \*\*Adhere to Legal and Financial Terms\*\*

Before participating in the \*\*Curate Your Space\*\* program, collectors are advised to review the full legal and financial terms. This includes responsibilities for damages, repair costs, and any potential legal fees arising from disputes. These terms are in place to safeguard both the collector's and the gallery's interests and ensure transparency throughout the process.

### \*\*Prohibitions\*\*

#### 1. \*\*Do Not Modify or Alter the Artwork\*\*

Collectors are prohibited from making any alterations or modifications to the artwork during the experience period. This includes reframing, re-mounting, or making any aesthetic changes to the piece. The artwork must remain in the exact condition it was delivered in, to preserve its authenticity and value. Any modifications could result in significant repair costs or diminish the artwork's value, for which the collector would be held responsible.

#### 2. \*\*Do Not Retain the Artwork Beyond the Agreed Period\*\*

The experience period is designed to give you ample time to enjoy and evaluate the artwork, but it is important to respect the agreed-upon timeframe. If you wish to extend the experience period or if you decide to purchase the piece, you must notify the gallery before the scheduled return date. Retaining the artwork beyond this period without prior approval may result in additional charges or penalties, including legal actions if necessary.

# 3. \*\*Do Not Display Artwork in Adverse Conditions\*\*



The artwork must be displayed in conditions that ensure its preservation. Avoid placing the piece in areas where it may be exposed to excessive light, humidity, temperature fluctuations, or any other potentially damaging elements. High-traffic areas or spaces where the artwork could be accidentally knocked over or damaged should be avoided. Failure to safeguard the artwork's environment could result in significant damage, for which the collector will be liable.

## 4. \*\*Do Not Attempt Unauthorized Repairs\*\*

In the unfortunate event that the artwork sustains damage during the experience period, collectors are prohibited from attempting any repairs on their own. All repair work must be conducted by professionals, coordinated through the gallery. Unauthorized repairs can further damage the piece, and may result in additional costs. If any damage occurs, report it to the gallery immediately so that we can handle the situation in accordance with best practices.

## 5. \*\*Do Not Use Inappropriate Shipping Methods\*\*

When returning the artwork, it is essential that you use only professional fine art shipping services. Improper packaging or shipping methods can lead to damage in transit, for which the collector will be held responsible. Make sure to use appropriate materials and trusted carriers that specialize in handling delicate and valuable works of art.

#### 6. \*\*Do Not Assume Ownership Prior to Purchase\*\*

The artwork remains the property of the gallery until the purchase is finalized. During the experience period, the collector does not have the right to transfer, sell, or otherwise claim ownership of the artwork. If you decide to purchase the piece, the sale will be completed through the gallery, following all necessary legal and financial procedures. Until then, the artwork must be returned in accordance with the terms outlined in the agreement.
